**During the 2020-2021 school year, over 37,000 students and families were reached through school-wide events or received social services referrals, crisis intervention and/or school supplies. Those 37,000 individuals received nearly 194,000 instances of support/supplies. Student achievement among 3,346 case-managed students included the following outcomes: 85% of students needing academic progress improved in academic achievement; 92% of students with school behavior risk factors and goals improved in school behavior; 86% of students with attendance risk factors and goals improved in attendance; 99% of students were promoted to the next grade, reducing student retention rates; 91% of seniors graduated.**
